Ofsted has raised concerns about Prevent duty engagement across the FE and training sector. A specific recommendation from the report is that providers should be better aware of the support the ETF can offer.


The report said: *'some providers viewed the duty as a list of conditions just to comply with and have adopted a 'tick-box' approach. This goes against the spirit of the government's guidance, which seeks to promote meaningful ways to reduce the specific risks of radicalisation and extremism for learners and the local community.'*

'There was a tendency to be over-reliant on online training packages. These packages provided only a basic awareness and understanding of 'Prevent'. Little thought was given to extra or bespoke training for staff.'
