This element of the T Level Professional Development (TLPD) offer will provide you with a good understanding of T Levels, so you can shape the direction of your organisation, support the wider leadership team and monitor progress and outcomes.

Course: Governors Providing T Levels

Who is it useful for?

- Governors, trustees and governance professionals who are or will be supporting leadership teams to implement T Levels.

Course outline:

This course is designed to provide governance professionals with the required level of information relating to T Level policy and implementation. It focusses on organisation wide internal and external strategic considerations, allowing governance professionals to both support and ensure robust challenge is given.

Study mode:

It is possible to study the content of this course both online and face-to-face*. The two course options are similar but not identical and there is considerable benefit to attending both courses.

We recommend you complete the online course first to be better prepared for the face-to-face event. Although this is not mandatory, it will maximise the impact of your CPD activity.

Recommended six hours of self-guided learning.
- Face-to-face event (C0932): Governors Providing T Levels
Three sessions, each lasting two hours.

- A framework to help support leadership teams to implement T Levels through educational performance and good financial management.
- Raise awareness of stakeholder management and workforce planning opportunities for T Level implementation.

There are no specific entry requirements for this course, however it is expected you would be leading the planning and implementation of T Levels within a Further Education provider. The TLPD offer is provided at no charge to ESFA funded providers. Face-to-face events are aimed at those delivering T Levels in 2020 and 2021.
