### Course: Understanding T Levels for Leaders and Governors in the Post-16 Sector

#### Who is it useful for?

- Senior leaders, governance professionals and stakeholders who are working in or with providers intending to deliver T Levels
- Senior leaders, governance professionals and stakeholders in non-T Level providers who have learners likely to progress onto T Levels.

#### Course outline:

This course is a first introduction to the T Level and wider technical education policy. It targets useful information for senior leadership and governance professionals, strategic considerations and changes they will need to make as T Levels are rolled out.
